Sessions will be led by Ms. Lisa Bishop, Assistant Professor (Pharmacy), MUN School of Pharmacy and Faculty of Medicine; Mr. Peter Browne, QC, civil litigation, labour, administrative law; Dr. Roger Butler, Associate Professor (Family Medicine), MUN Faculty of Medicine; and, Dr. Kristopher Luscombe, Assistant Professor/Clinical Education (Psychiatry), MUN Faculty of Medicine.

The CME program will be held from 8:30 a.m. to 12:15 p.m. in Salon D of the Sheraton Hotel in St. John's. Registration for the CME is \$56.50 for physicians and is free for residents and medical students. Registration includes breakfast, lunch and a nutrition break.
