TO: FEE-FOR-SERVICE AND SALARIED PHYSICIANS

RE: IMPLEMENTATION OF THE NEW MEMORANDUM OF AGREEMENT

The Government of Newfoundland and Labrador and the Newfoundland and Labrador Medical Association have signed a new Memorandum of Agreement (MOA) covering the period of October 1, 2017 to September 30, 2023. In accordance with the MOA, all rate changes are retroactive to December 30, 2021.

Fee-for-Service Biweekly Adjustments

The table below shows the percentage adjustment effective December 30, 2021 for each specialty, for purposes of fee code allocation. These percentage increases will be applied to the total bi-weekly payments to Fee-for-Service Physicians until such time as the microallocation process is completed.

As of June 29, 2022, physician can begin billing for their services at the new rates. Biweekly adjustments will be issued as a financial adjustment by MCP starting July 29, 2022 (PP09). If payments are delayed for technical reasons, they will be issued on the earliest possible pay period.
