This includes developing and providing education, physician outreach, programs and innovative approaches to meet the recovery and medical needs of injured workers.

- Provides leadership and accountability for outcome management, performance management, operational planning, and strategic planning at WorkplaceNL.
- Advances WorkplaceNL's strategic plan by forming strong partnerships with agencies and physicians including family physicians, specialists, the Government of Newfoundland and Labrador, Regional Health Authorities, other health disciplines, and the NLMA.
- Works as part of a health care team to facilitate early and safe return to work, monitor performance of contractors, and develop and implement client-centered initiatives to maximize the health and well-being of injured workers.
- Evaluates, analyzes and interprets complex medical issues and recommends solutions.
- Identifies needs, researches and investigates options, and establishes initiatives to prevent and manage occupational disease.
- Provides opinions and recommendations to our decision-making employees on issues of medical impairment and disability, cause, etiology, diagnosis, treatment, care pathways and prognosis.

- A member in good standing with College of Physician and Surgeons of Newfoundland and Labrador.
- Holds or is working towards the Canadian Board of Occupational Medicine (CCBOM) certification.
- Preferred experience in assessing and treating musculoskeletal injuries; specific medical experience with work-related injuries; and experience developing and providing training and education in the field of occupational medicine.
- A minimum of five years recent experience in Occupational Medicine with a
  particular emphasis on disability management, management and diagnosis of
  occupational disease, management of workplace injuries, treatment of
  musculoskeletal injuries, and successful early and safe return to work.
